### **OBJECTIVE:**

To assist the Chief Aviation Safety, Rules & Regulations in maintaining a comprehensive technical document library concerning aircraft operations, airworthiness, licensing and all records, directives and the other related information. Support the BCAA oversight and ensure that aircraft, ground facilities and company policies and practices meet the minimum requirements as per International Civil Aviation Organization (ICAO) Standards and Recommended Practices (SARPS) and Bahrain Air Navigation Regulations (ANTR) and standards.

## **Duties and Responsibilities:**

Enforces the Civil Air Law issued by virtue of Law No. 14 of 2013 to ensure compliance with the ANTR and duly constituted Ministerial Directives.



Investigates alleged violations to determine whether or not an offense occurred and make recommendations accordingly.

Participate in investigation as directed by Director of Aerolicensing.

Formulate and establish regulatory changes to effect NPA (New Proposed Amendments) as per Civil Air Law.

- a) To obtain, maintain and update national and international civil aviation regulatory documents and manuals.
- b) To ensure all documents and procedures are recorded, updated and distributed to copy holders.
- c) To communicate through Bahrain CAA main library and receive all ICAO correspondence.
- d) To record action taken in revisions/updates for all ICAO Annexes 1, 6, 7, 8, and 13 and any other related State letters.
- e) To ensure that all manuals and soft copies are maintained systematically for quick and easy reference.
- f) To maintain and archive records for all accident and incident.
- g) To assist the Chief Aviation Safety, Rules & Regulations in follow up on action taken for compliance with accidents and incidents, recommended by the Investigator.
- h) Assist Chief Aviation Safety Rules and Regulation in developing and writing rules, regulations, procedures and compilation of manuals.
- To perform other related duties assigned by the Chief Aviation Safety, Rules & Regulations and Investigations Inspector

#### **Education:**

- Bachelor's degree from a recognized university with a specialization in either law degree, aeronautical, mechanical or electrical engineering or computer sciences; preferably degree in law and/or international law.
- o Post-secondary education in an aviation or related program to the position.
- o Other degrees attained.

### Knowledge:

- Have, or acquire as necessary, extensive, and solid knowledge of Bahrain Civil Air Law, Bahrain Air Navigation Regulations (ANTR) and its associated standards, and ICAO SARPS and International Law.
- o Experience in drafting a civil aviation regulatory requirements, concepts, and law principles based on the following:
  - Applying a risk-based approach to regulation
  - Minimizing the regulatory burden
  - Increasing the delegation of regulatory authorities
  - Increasing communication with aviation community
- o Knowledge of risk management techniques
- Knowledge of Safety Management Systems (SMS) employing prescriptive and performance based regulations
- o A good command of oral and written English is essential
- o Computer literacy and word processing skills

- Experience in any of the following aviation disciplines: flight operations, airworthiness, regulatory, air traffic control system.

### Conditions of employment

Candidates must meet and maintain the conditions of employment throughout their employment

- Security clearance
- o Must maintain a valid Airline Transport Pilot license (ATPL) if applicable
- o Must hold a valid Passport for international travel
- o Must hold a valid Driver's license
- o Willingness and ability to work overtime, often on short notice.
- Willingness and ability to travel abroad on a regular basis.
- Willingness and ability to maintain professional aviation currency if applicable
